PROOF OF CLAIM FORM FOR CASH FOUND AT PROPERTY

Pursuant to the Court's Order Granting Receiver's Motion for Entry of Order Approving Protocol for Processing and Returning Personal Property Items to Victims and Cash Found at the Property, dated October 1, 2021, entered in Case No. 2021-015089 (Fla. 11th Jud. Cir. Ct.), the Court required that "any individual claiming ownership to any of the cash found at the property shall submit a Proof of Claim for Cash Form ("POC Forms"), which will be posted on the Receiver's website, along with any required documentation to the Receiver." Submission of this POC Form does not create an entitlement to any of the U.S. Currency found at the Property. The Court may require additional evidence and information in determining if the rightful owner(s) of the U.S. Currency can be identified and how to distribute the funds.

The deadline for the submission of POC Forms, related documentation and identification is Midnight Eastern Time November 30, 2021. Submissions *received* after Midnight Eastern Time on November 30, 2021 will not be considered.

Note this deadline does not apply to "easily identifiable U.S. currency" which is defined as U.S. Currency found in a wallet, purse, box, container or other object that also contains one or more items which identify the owner, such as a driver's license, passport or credit card. Easily identifiable cash will be returned to the rightful owner(s) (or the validly appointed Personal Representative of the owner's estate or such other person who is legally entitled thereto) upon the Receiver's receipt of the funds from the Department of Treasury.
