**RECEIVER'S MOTION FOR ENTRY OF AN ORDER  
AUTHORIZING MIAMI-DADE COUNTY TO RETURN  
RECOVERED PROPERTY ITEMS IDENTIFIABLE TO INDIVIDUALS**

Michael I. Goldberg (the "Receiver"), pursuant to Rule 4 of the Complex Business Litigation Rules, seeks entry of an Order authorizing Miami-Dade County to return personal property items and foreign currency coins recovered in the rubble and/or vehicles at the collapse site to the extent the County was able to identify the owners. In support thereof, the Receiver states:

1. At a hearing conducted on July 2, 2021 (the "Commencement Date"), in the captioned cases, the Court ordered the appointment of Michael I. Goldberg as Receiver for the Association. Following the hearing, the Court entered an order formally appointing Mr. Goldberg as Receiver.

2. This receivership is the result of multiple lawsuits that were filed after the tragic collapse of a portion of the real property with a physical address of 8777 Collins Avenue, Surfside, Florida 33154 (the "Property").

3. Following the collapse of the Champlain Tower South Condominium, Miami-Dade County recovered thousands of personal property items from the rubble, as well as vehicles at the Property. In order to facilitate the return of personal property and in accordance with EPA guidelines, the County underwent the task of decontaminating recovered hard items.

4. If personal property and a form of identification were contained within an enclosed receptacle, the personal property will be returned to the individual listed on the identification. As for vehicles, the County used the vehicle identification number (“VIN”) to determine the registered owner(s) of the vehicles and therefrom determine the ownership of personal property items found within, as detailed in **Composite Exhibit A**.<sup>1</sup>

5. Therefore, and in accordance with this Court’s Order dated October 1, 2021, the Receiver respectfully requests this Court authorize Miami-Dade County to release the recovered decontaminated property items which have been identified as described above and as enumerated in Composite Exhibit A.

6. Neither the Receiver nor the County warrants the safety of the personal property items and/or that they are free of all bio-hazardous materials despite the County’s completion of the decontamination process. Accordingly, it is requested that the Court’s order approving the return of personal property provide that an individual’s acceptance of the property shall constitute a waiver of any and all claims against the County and the Receiver with respect to the personal property and coins, including but not limited to, any claims or damages relating to any bio-hazardous materials, such as asbestos and mold, remaining on the personal property.

7. The County and the Receiver also request that the Court’s order approving the release of property items provide that the Receiver and the County are not responsible for the turnover of personal property or currency inadvertently to the wrong person so long as they followed the procedures set forth in the applicable Court Orders.

8. Upon issuance of an Order on this Motion, the Receiver, to the extent possible<sup>2</sup>, will contact the individuals referenced in Composite Exhibit A to provide them the contact information for the County so that the owners and/or court-appointed personal representatives can coordinate retrieval of their items from Miami-Dade County. This Motion and Order will be posted on the Receiver's website.

WHEREFORE the Receiver respectfully requests that the Court grant this Motion, thereby authorizing the County to return the items listed in **Composite Exhibit A** to the respective individuals listed therein. The Receiver respectfully requests this Court grant any other and further relief it deems just and proper.
