PLAINTIFFS' MOTION FOR AUTHORITY TO RETAIN EITHER ROBERT L. PARKS, ESQ., AND/OR RETIRED JUDGE JOHN W. THORNTON AS CLAIMS ADMINISTRATOR

Undersigned appointed counsel, representing the putative class members, hereby moves this Honorable Court for an order authorizing the retention of either Robert L. Parks, Esquire, and/or Retired Judge John W. Thornton as Claims Administrator and in support thereof state as follows:

- 1. On March 8th, 2022, the Plaintiffs filed a Motion to Appoint a Claims Administrator to develop and implement a claim evaluation protocol that will assist with the administration of the claims put forth by the wrongful death subclass.
- 2. On March 10th, 2022, this Honorable Court entered an Order granting the Plaintiffs' Motion to Appoint Claims Administrator. Said Order required that leadership counsel meet, confer, interview, and vet potential Claims Administrator(s) in order to ensure that the potential Administrator is respected, experienced, capable, and free of any conflicts of interest. This Honorable Court's Order further required that leadership counsel present their recommendations by March 30th, 2022.
- 3. Following an extensive vetting process and multiple discussions with potential Claims Administrators, leadership counsel recommends that either Robert L. Parks, Esquire, and/or Retired Judge John W. Thornton be appointed as Claims Administrator.

- 4. Attorney Parks, a graduate of Georgetown University Law Center, has over 50 years of experience in mass torts, aviation, wrongful death, and commercial litigation claims. He is a recipient of the Legal Legends Award from History Miami's 11th Judicial Circuit Historical Society, which recognizes members of the legal community who have made significant contributions to the law, legal system or the administration of justice in the 11th Judicial Circuit for at least 25 years or more. A copy of Mr. Parks' biography is attached hereto as "Exhibit A."
- 5. Judge Thornton, a graduate of the University of Miami School of Law (1977), served as a Circuit Court Judge for the Eleventh Judicial Circuit of Florida from 2007 to 2020 and presided over class action, mass tort, construction, and complex business and commercial cases. A copy of Judge Thornton's biography is attached hereto as "Exhibit B."
- 6. Both Mr. Parks and Judge Thornton are well respected, experienced, and capable of handling this matter. Furthermore, Mr. Parks and Judge Thornton reported no potential conflicts in serving as Claims Administrator.
- 7. Mr. Parks and Judge Thornton have agreed to serve as Claims Administrator for a reduced hourly fee, which will be negotiated further after selection and the scope of responsibilities further defined.
- 8. Leadership counsel has no preference as to which Claims Administrator should be appointed and leaves it to this Honorable Court's discretion as to which of the two should be selected.
- 9. In the event the appointed Claims Administrator is unable to fulfill his duties secondary to unforeseen issue(s) or requires assistance in the timely completion of his duties, leadership counsel requests that the Alternate Claims Administrator be substituted.

WHEREFORE, Undersigned counsel respectfully moves this Honorable Court for an order authorizing the retention of either Robert L. Parks, Esquire, and/or Retired Judge John W. Thornton as Claims Administrator.


