**ORDER ON SUPPLEMENTAL PETITIONS FOR
ATTORNEY'S FEES AND COSTS**

Pursuant to this Court's August 3, 2022 *Sua Sponte* Order, certain firms have applied for attorney's fees and costs incurred subsequent to the filing of class counsel's fee petition and/or in the claims process. The Court, having carefully reviewed each firm's application, and being otherwise intimately familiar with the quality of the services each provided, hereby **ORDERS**:

1. Friedland Carmona is awarded the sum of Forty-Seven Thousand Three Hundred Fifty-Five Dollars (\$47,355.00) for fees and costs incurred in presenting its clients' damage claims.
2. The Moskowitz Law Firm is awarded the sum of One Million Two Hundred Eleven Thousand Eight Hundred Eighty Dollars and Eighty Cents (\$1,211,880.80) for attorney's fees and costs incurred in presenting its clients' damage claims.

3. Heise Suarez Melville, P.A. is awarded the sum of Eighty-Nine Thousand Seven Hundred Twelve Dollars and Twenty-Eight Cents (\$89,712.28) for attorney's fees and costs incurred in presenting its clients' damage claims.
4. Saltz Mongeluzzi Barrett & Bendesky P.C. is awarded the sum of Three Hundred Seventy Four Thousand Nine Hundred Ninety Dollars and Forty-Seven Cents (\$374,990.47) for attorney's fees and costs incurred in presenting its clients' damage claims.
5. Goldberg & Rosen, P.A. and Todd Rosen Law Group are awarded the sum of Two Hundred Eighty-Seven Thousand Three Hundred Twenty-Five Dollars and Eighty-Nine Cents (\$287,325.89) for attorney's fees and costs incurred in presenting its clients' damage claims.
6. Searcy Denney Scarola Barnhart & Shipley, P.A. is awarded the sum of Three Hundred Twenty-Five Thousand One Hundred One Dollars and Nineteen Cents (\$325,101.19) for attorney's fees and costs incurred in presenting its clients' damage claims.
7. Podhurst Orseck, P.A. is awarded the sum of Nine Hundred Forty-Six Thousand Six Hundred Thirty-Three Dollars and Six Cents (\$946,633.06) for attorney's fees and costs incurred in presenting its clients' damage claims.

8. Silva & Silva, P.A. is awarded the sum of One Million One Hundred Twenty Thousand Three Hundred Fifty-One Dollars and Ninety Five Cents (\$1,120,351.95) for attorney's fees and costs incurred in presenting its clients' damage claims.
9. Grossman Roth Yaffa Cohen, P.A. is awarded the sum of One Million Five Hundred Twenty-Three Thousand Eight Hundred Eighteen Dollars and Thirty-Seven Cents (\$1,523,818.37) for attorney's fees and costs incurred in presenting its clients' damage claims.
10. Pita Weber & Del Prado is awarded the sum of Forty-One Thousand Three Hundred Twenty-Eight Dollars and Twenty Cents (\$41,328.20) for attorney's fees and costs incurred in presenting its clients' damage claims.
11. Edwards Pottinger LLC is awarded the sum of Eighty-Six Thousand One Hundred Ninety-Eight Dollars and Nine Cents (\$86,198.09) for attorney's fees and costs incurred in presenting its clients' damage claims.
12. Colson Hicks Eidson P.A. is awarded the sum of Two Hundred Forty Thousand Seventy Dollars and Thirty-Three Cents (\$240,070.33) for attorney's fees and costs incurred in presenting its clients' damage claims.
13. Velasquez Dolan, P.A. is awarded the sum of One Hundred Thirty-One Thousand Four Hundred Fifty-Three Dollars and Thirty-Seven Cents

(\$131,453.37) for attorney's fees and costs incurred in presenting its clients' damage claims.

14. Romano Law Group and Robes Law Group, PLLC are awarded the sum of Four Thousand Eight Hundred Forty-Five Dollars and Twenty-One Cents (\$4,845.21) for costs incurred in presenting its clients' damages claims. The firm may apply for attorney's fees if it so chooses.
15. Brad Sohn Law Firm is awarded the sum of Sixty-Two Thousand Eighty Dollars and Eleven Cents (\$62,080.11) for attorney's fees and costs incurred in presenting its client's damage claim.
16. Kozyak Tropin & Throckmorton is awarded the sum of Three Hundred Ninety-Nine Thousand Four Hundred Sixty-Two Dollars and Forty-Eight Cents (\$399,462.48) for attorney's fees and costs incurred on behalf of the class, and as co-lead counsel, subsequent to the filing of class counsel's fee petition.
17. Leesfield Scolaro, P.A. is awarded the sum of Twenty-Two Thousand Forty-Three Dollars and Eighty-Six Cents (\$22,043.86) for attorney's fees and costs incurred in presenting its client's damage claim.
18. Gary, William, Parenti, Watson, Gary & Gillespie, P.L.L.C. and the Porter Law Firm are awarded the sum of Three Hundred Forty-One Thousand

Nine Hundred Twenty-Six Dollars and Sixty-Five Cents (\$341,926.65) for attorney's fees and costs incurred in presenting its clients' damage claims.

19. Kluger, Kaplan, Silverman, Katzen & Levine, P.L. is awarded the sum of Forty-Two Thousand Seven Hundred Fourteen Dollars and Seventy Cents (\$42,714.70) for attorney's fees and costs incurred in presenting its client's damage claim.

20. Weissman & Dervishi P.A. is awarded the sum of Twenty-Five Thousand Two Hundred Sixty-One Dollars and Eighty-Three Cents (\$25,261.83) for services rendered to its class member clients, including assisting in presenting their damage claims.


21. Rodolfo Suarez, Jr., P.A. d/b/a Suarez Law is awarded the sum of Two Thousand Two Hundred Fifty Dollars (\$2,250.00) for services rendered its claim member client, including assisting in presenting their damage claim.

The Court finds that the work of these attorneys benefited all class members as a whole, and that attempting to separate the work done on each case, and allocate the time/costs to particular claimants, would require more administrative time and effort than warranted, and that doing so would have no material impact on the net amount to be received by each class member. The Receiver shall therefore pay these awards "off the top," and shall then pay Class Members their proportionate share of all remaining funds – meaning funds available for distribution after all fee/cost

awards, including the Receiver's award, class counsel's awards, and these supplemental awards, have been paid.

The Court again commends these outstanding members of our Bar for their professionalism, diligence and excellent work. They have provided a great service to our community and legal system in general and, more importantly, to the victims of this tragedy who, in a time of crisis, were in desperate need of sage counsel. It has been a privilege to have had each of these firms appear before the Court in this most difficult case. They exceeded the Court's every expectation.
