CLASS COUNSEL'S MOTION FOR THE REIMBURSEMENT OF COSTS

Undersigned appointed Class Counsel move for an order directing payment from the

Receivership Estate to reimburse Class Counsel for costs advanced or incurred to achieve the

settlement in this case and/or in the representation of class members in the claims process, and

state as follows:

The Court ordered on August 30, 2022, that certain "supplemental" fees and costs

submitted by Class Counsel appointed to the Plaintiffs' Steering Committee ("PSC") and retained

non-PSC counsel be paid from the Receivership Estate ("Supplemental Fee Order"). This

Supplemental Fee Order did not, however, reimburse PSC Counsel for all their common benefit

and/or client benefit costs. Because this Court previously ordered that Class Counsel's reasonable

costs would be reimbursed,1 and these outstanding costs were reasonably incurred by PSC firms

and timely submitted to the Court, they should now be ordered to be paid from the Receivership

Estate.

¹ This Court ordered at the outset of this case that Plaintiffs' Counsel's reasonable expenses would be eligible for reimbursement from the Association's Receivership Estate. *See* July 16, 2021, Order ("Counsel will also be reimbursed all out of pocket expenses from the receivership estate."); *see also* Aug. 29, 2021, Case Mgmt. Order. Additionally, Article 13 of the June Settlement Agreement, entitles Class Counsel to recover fees and costs from the Settlement Fund.

Common Benefit Costs

On June 12, 2022, Class Counsel filed a Motion for Final Approval of Class Settlement and Application for Award of Attorneys' Fees, Costs, and Expenses (the "June Fee Application"), in which they asked the Court to award fees and costs. The costs incurred or advanced by each PSC firm were detailed in "Exhibit B" to the declarations of the PSC members attached to the June Fee Application.

As set forth in that fee application, these costs are of the type reasonably incurred in class actions and were necessarily advanced by counsel in furtherance of the prosecution of the case and the settlement. These outstanding common benefit costs are as follows:

The relevant cost itemizations for these PSC firms, submitted on June 12, 2022, are attached here again as composite **Exhibit A.**

Client Benefit Costs

One PSC firm, Grossman Roth Yaffa Cohen, P.A., also seeks reimbursement for client benefit costs incurred in connection with the claims hearings (i.e. videographer servicers, expert fees, etc.), which were itemized and timely submitted to the Court *in camera* on August 26, 2022, but were not reimbursed by the Court's Supplemental Fee Order. It appears that certain client costs were reimbursed as a part of that Fee Order, but those of this firm were not, which total

\$218,362.50.² Grossman Roth's cost-ledgers for each of their clients are being re-submitted contemporaneously herewith *in camera*, for the Court's review.

WHEREFORE, Class Counsel respectfully requests that the Court enter an order directing that the above detailed costs advanced by Class Counsel and timely submitted to the Court, be reimbursed to Class Counsel from the Receivership Estate.
